CR CFR Title Distribution by DLC, Nayagarh

The District Level Committee (DLC) of Nayagarh, Orissa distributed fourteen Community Rights (CR) and Community Forest Resource Rights (CFRR) covering twenty-four villages of the district in the first phase of distribution on November 2, 2021.

The historical status of the day is established by the fact that titles were distributed to Joint Forest Protection & Management committees for the first time in the country. It was also the first time that community forest right titles were distributed to OTFDs.

The titles had been previously handed over to Mr. Arakita Sahoo, the secretary of the MMJSP by the collector which were distributed on 22nd November, 2021 in the presence of the hon'ble MLA, the DWO, and various other authorities.
