Introductory Meetings. Orientation & Training **Programmes**



We have conducted a number of Introductory meetings, collective meetings for various MFP value addition projects, claim facilitation for FRC, CR, and CFRR, and collective building for forestbased livelihoods.

Training programs have also been conducted for the reformation of the FRC committee, support to primary groups, FRA orientation processes, VDVK Training Programme in presence of PA ITDA, S/O ITDA, LDA, and other governmental authorities.

BBS Volunteer Review Meeting

Vasundhara conducted a volunteer review meeting for planning purposes.

In the meeting it was decided to conclude the audit of 37 remaining primary PGs. The target for PG formation was set at 8. A region specific plan was developed, along with the completion of product profiling. A record estimation for the PG was also in the agenda, It was also decided that a meeting needs to be organised for Nahnaguda and Surupa PG for a potential estimation.

Did You Know?

BanaSita Collective Meeting

Vasundhara conducted a Collective meeting for planning purposes.

The Storage Unit is being built though complete community action. Different responsibilities have been distributed among different members. This storage unit will cover 22 PGs in the Laimura and Jharagogua. The estimated budget has been set around 4-5 lakhs.

The discussions with the Forester regarding cleaning up some surrounding vegetation for the purposes of building the storage unit.

BMS Union Volunteer Review Meeting

A review meeting was conducted by the BMS Union to review the activities and the plans of the volunteers with respect to livelihood security. Focus was on cash Book Keeping, Accounts Training.



Discussion with Lok Sanghatan - Forest rights, Jashuguda

A discussion with Lok Sanghatan - Forest rights, Jashuguda was held regarding the opportunities around livelihoof security of forested communities in the area. The Livelihood Team Leader attended the meeting.



Annual Planning Meeting

Vasundhara conducted an annual planning meeting at all of it's operational areas. The thematic team leaders along with the Documentation and Research team met at each of these areas to streamline the activities for the year,

The main focus was on determining the targets for the year in consultation with the field team in the respective areas.

Documentation and Research plans were discussed with the teams to diversify the scope of intervention in the areas.





Facilitation of Habitat Right Claims in Orissa

Vasundhara is facilitating claim making process for the habitat rights of the 13 PVTGs in Orissa in collaboration with SCSTRTI, Bhubaneswar since April 2021.

Till now, claims for habitat rights in 15 micro-projects out of 20 have been completed. Out of those 15 microprojects, habitat rights claims have been submitted in 12 micro-projects at SDLC, i.e. the claim of Chuktia Bhunjia in CBDA, Nuapada; Paudi Bhuyan in PBDA, Deogarh; Hill Khardia and Mankirdia in HKMDA, Mayurbhani; Saura in TDA, Tumba, Ganjam; Saura in SDA, Chandragiri, Gajapati; Juanga in JDA, Keonjhar; Juanga in JDA, Dhenkanal: Bonda in BDA. Malkangiri; Didayi in DDA, Malkangiri; Kutia Kandha in KKDA, Belghar, Kandhamal; Paudi Bhuyan in PBDA, Anugul.



In the process of rights determination, it was found that there is no habitat concept in Lodha, Mayurbhanj; Lanjia Saura, Serango, Gajapati; Lanjia Saura, Putasingh, Rayagada, and Birhor, Jajpur.

The habitat rights claims are ready for submission for the Paudi Bhuyan, Sundargarh and Juang, Jajpur. The claims for Dongria Kondh in DKDA, Parsali and Chatikona in Rayagada district; for Kutia Kondh in KKDA, Lanjigarh in Kalahandi district; for Paudi Bhuyan in PBDA, Banspal in Keonjhar districts are in

Gradually, In the presence of an organised approach, they are being able to realise the actual worth of their products.




Nalini Mausi Obituary

Among all of the news, the CSO sector in Orissa was left stunned by the passing away of Nalini Mausi, a warrior and champion in Community Forest Protection and huge contributor to democratic forest practices in the area.

Vasundhara recently facilitated a study on the Forest Rights Act in collaboration with Council of Social Dvelopment, Hyderabad. The report assesses the situation in 11 states in India with regards to FRA implementation.









Facilitation of the **Conversion of Forest Village** to the Revenue Village

Vasundhara facilitated the process of the conversion of forest village to revenue village in Eripiput village in Kashipur block under Ravagada district administration in collaboration with the Rayagada district administration. The organization extended training and other technical support in the district to facilitate the conversion process. Maximum of the forest villages are situated in Kashipur block in Rayagada district. Vasundhara organized training programme for the field level officials of revenue department, forest department and welfare department including the FRA Cell coordinators at Kashipur.



The implementing team, then, started the process at field level. Till now, claims from 4 forest villages in Kashipur block have been submitted at DLC for the conversion into revenue village.
