Habitat rights to 7 PVTG in Odisha by chief minister

Habitat Rights to Seven PVTGs on Birsa Munda's 150th Birth Anniversary. In a landmark move with the 150th Birth Anniversary of tribal icon Birsa Munda, the Odisha Chief Minister distributed Habitat Rights Titles to seven Particularly Vulnerable Tribal Groups (PVTGs) during the State-level Janajatiya Gaurav Diwas celebrations at Janta Maidan, Bhubaneswar. The beneficiary communities include the Juanga tribes from Kendujhar and Jajpur, Kutia Kondh from Kandhamal, Chuktia Bhunjia from Nuapada, Khadia and Mankirdia from Mayurbhanj, and

Special Gram Sabhas mark Birsa Munda's 150th Birth Anniversary



Special Gram Sabha sessions are being conducted across 63,843 villages in India, including 7,667 villages in Odisha, commemorating the 150th birth anniversary of legendary tribal leader Birsa Munda. Vasundhara, actively working in 2,859 villages, is participating in this nationwide celebration of Janjatiya Gaurav Divas on November 15.

Born in 1875, Birsa Munda, reverently known as Bhagwan Birsa Munda among tribal communities in Jharkhand and Odisha, left an indelible mark on India's tribal rights movement. His unwavering dedication to protecting tribal rights and his role as a freedom fighter continue to inspire generations.

Tribal enterprises get a boost with new processing units in Kujamendhi





MLA Ramesh Behera inaugurated two significant rural enterprises in Kujamendhi Panchayat on November 6th - the Khali Dona Pressing Unit in Kuradhinisha village and an Oil Extraction Machine at Ambalimba village.

During the launch ceremony, Mr. Behera announced plans to integrate the oil production with Adisha, the Tribal Development Co-operative's brand, which will expand market opportunities for local producers. The initiative aims to strengthen tribal entrepreneurship in the region.

The MLA also outlined support for aspiring entrepreneurs, inviting villagers to submit written applications for business ventures under the MSME scheme. Furthermore, he committed to establishing a central godown in Daspalla to facilitate storage and distribution of leaf plates.
