### Habitat rights provided to Mankidia

In a landmark decision, the Mankidia community, a Particularly Vulnerable Tribal Group (PVTG), was formally provided habitat rights under the Forest Rights Act, 2006. The rights were officially conferred during a ceremony in Baripada, attended by Urban Development Minister Krushna Chandra Mohapatra and Forest Minister Ganesh Ram Singkhuntia.

This legal recognition gives the Mankidia tribe legitimate access to their ancestral forests for traditional practices and livelihood activities, marking a significant shift from their previous

status where they were restricted from using forest resources despite their PVTG classification. "The community will now freely perform their traditional and cultural activities in the landscape," noted Y Giri Rao, Executive Director of Vasundhara. The Mankidia becomes the



second PVTG in Odisha to receive habitat rights, with four other communities already approved by district-level committees.

The rights were granted under Section 2(h) of the Forest Rights Act, which defines habitat as areas comprising customary and other habitats in reserved and protected forests used by primitive tribal groups and pre-agricultural communities.

A series of intensive Forest Rights Act (FRA) implementation activities were carried out across multiple blocks in the Mayurbhanj district, marking significant progress in recognizing Community Rights (CR) and Community Forest Resource (CFR) rights.

The district witnessed numerous gram sabha meetings, claim verifications, and Tahasil Level Monitoring Committee (TLMC) sessions from September 2 to 8, 2024. Notable activities included joint field verifications at Pahadpur village in Kusumi Tahasil and claim-making processes in Raibadi village under Lupung GP of Tiring Tahasil.

Several TLMC meetings were conducted across tahasils including Jamda, Bisoi, and Sukruli, where officials discussed CR-CFR claim processing, GPS mapping, and pending Individual Forest Rights (IFR) cases. These meetings saw participation from key stakeholders including Tahasildars, Block Development Officers, Forest Department officials, and FRA coordinators.

Final gram sabhas were completed in multiple villages including Kuldiha,

Sundhal, and Deokundi, where Community Forest Resource Management Committees (CFRMC) were formed. The process involved extensive participation from local authorities, FRA coordinators, community volunteers, and villagers.
